Christmas Marketplace, Dec 1-2, 2017

The Cowan Christmas Market to be held in the Monterey Station on December 1 & 2, 2017. The booth size is 10' x 10'. Booth fees are \$40 for one booth and \$75 two booths. The Monterey Station can accommodate 60 booths. Each booth will have electricity; you are encouraged to decorate your booth. Each vendor must furnish their own tables, display equipment and chairs. Tent frames are permissible; however the canopy shall not be used. Booths 45-50 will be reserved as a food court.

For consultants of catalog businesses, such as Mary Kay, Pampered Chef, Avon, etc, only the first receipt of application and fee will be accepted for these products.

To select a booth, vendors shall refer to the Vendor page on <http://cowanparade.org> and scroll down to the list of reserved booth to locate available booths.

A member of the Cowan Christmas Market vendor committee will call vendors in order of receiving completed application and fees. At such time, you will be assigned a booth location and the vendor list on the website shall be updated. The Cowan Christmas Market committee has the right to reassign vendor booth numbers to ensure similar vendor products are in not near each other.

No refunds for cancellation after November 1, 2017.

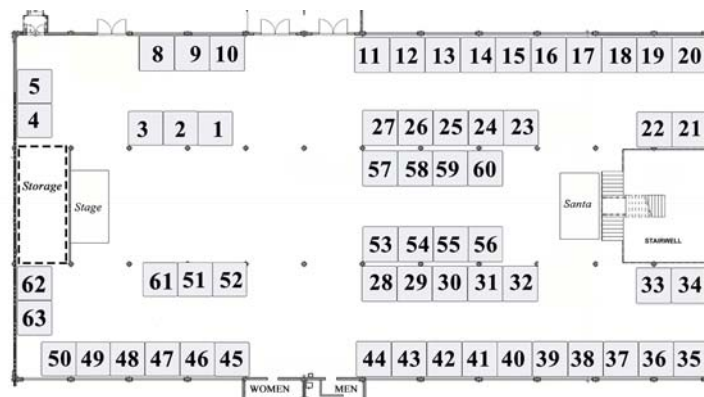
The vendor committee encourages each vendor to sponsor a door prize. Please supply a business card with the door prize written on the back side. Each winner will be directed to your booth to claim the prize.

Set up times at Monterey Station will be Thursday November 30 from 10:00 am to 6:00 pm, and Friday, December 1 starting at 10:00 am. Each booth will be marked with the vendor name.

The Cowan Christmas Market hours will be Friday December 1 from 3:30 pm to 9:00 pm. Saturday hours will be 10:00 am to 4:00 pm. Vendors are required to have their booths open both days.

The Cowan Christmas Parade and Market Committee reserve the right to decline or prohibit any vendor merchandise that, in the opinion of the Committee, is not professional or appropriate for the Cowan Christmas Market.
